TIGER RESERVES

TIGER (PANTHERA TIGRIS)

- ✓ Tigers are widely distributed across India, from the Himalayas to the rainforests of the southern Western Ghats and from the dry forests of Rajasthan to the moist forests of north-east India.
- ✓ IUCN Status: Endangered
- ✓ Included in Schedule I of the Indian Wildlife (Protection) Act, 1972 and in Appendix I of the Convention on International Trade in Endangered Species of Flora and Fauna (CITES).



ABOUT TIGER RESERVES:

- ✓ Tiger reserves are areas that are notified for the protection of the tiger and its prey, and are governed by Project Tiger, which was launched in 1973.
- ✓ Initially, nine tiger reserves were covered under the project, which has now increased to 53 in 18 tiger range states.
- ✓ Tiger reserves are notified by State Governments as per provisions of Section 38V of the Wildlife (Protection) Act, 1972 on advise of the National Tiger Conservation Authority (NTCA).
- ✓ No alteration in the boundaries of a tiger reserve shall be made except on a recommendation of the NTCA and the approval of the National Board for Wild Life.
- ✓ No State Government shall de-notify a tiger reserve, except in public interest with the approval of the NTCA and the National Board for Wild Life.
- ✓ A Tiger reserve includes:

a) Core zone

- Core or critical tiger habitat areas are established on the basis of scientific and objective criteria and are required to be kept inviolate for the purposes of tiger conservation without affecting the rights of the Scheduled Tribes or other forest dwellers.
- These areas are **notified by the State Government** in consultation with an Expert Committee (constituted for that purpose).
- b) Buffer zone
 - Peripheral area to critical tiger habitat or core area, where **a lesser degree of habitat protection** is required to ensure the integrity of the critical tiger habitat with adequate dispersal for tiger species.
 - It aims at promoting **co-existence between wildlife and human activity** with due recognition of the livelihood, developmental, social and cultural rights of the local people.
 - **The limits of such areas** are determined on the basis of scientific and objective criteria in consultation with the **concerned Gram Sabha and an Expert Committee** constituted for the purpose.

NTCA:

- ✓ The National Tiger Conservation Authority is a statutory body under the Ministry of Environment, Forests and Climate Change constituted under enabling provisions of the Wildlife (Protection) Act, 1972, for strengthening tiger conservation.
- ✓ National Tiger Conservation Authority is set up under the Chairmanship of the Minister for Environment and Forests.
- ✓ The Authority will have eight experts or professionals having qualifications and experience in wildlife conservation and welfare of people including tribals, apart from three Members of Parliament.
- ✓ The Inspector General of Forests, in charge of project Tiger, will be ex-officio Member Secretary.



📥 DO YOU KNOW?

✓ The National Board for Wildlife (NBWL) is chaired by the Prime Minister and the vicechairman of the NBWL is the Minister of Environment.

TIGER CENSUS 2022

- ✓ The tiger population in India grew by 200 from 2018 to 2022, according to the fifth cycle of the All India Tiger Estimation (2022) released in April 2023.
- ✓ The number of tigers in India was 3,167 in 2022, up from 2,967 in 2018, the report showed.
- ✓ The growth rate slowed to 6.7% in the four years from 2018 to 2022, from around 33% during 2014-2018.
- ✓ States with the highest population of Tigers in India
 - Madhya Pradesh >> Karnataka >> Uttarakhand >> Maharashtra >> Tamil Nadu
- ✓ About Tiger Census:
 - The national tiger census is conducted **once every four years.**
 - The nation-wide tiger census was earlier held in **2006**, **2010**, **2014**, **2018**.
 - Conducted by:
 - The National Tiger Conservation Authority (NTCA) conducts tiger censuses in partnership with state forest departments, conservation NGOs, and the Wildlife Institute of India (WII)
